RULES FOR ST. JOHN AND HOME HEIGHTS PARKS

DEPOSIT WILL BE FORFEITED IF ANY OF THESE RULES ARE VIOLATED

1. ALCOHOLIC BEVERAGES ARE NOT PERMITTED IN A PARK WITHOUT A PERMIT FROM THE CITY MANAGER. **GLASS CONTAINERS ARE PROHIBITED IN THE PARK.**
2. AREA IS TO BE CLEANED OF TRASH & DEBRIS BEFORE LEAVING.
3. OPEN FIRES ARE NOT PERMITTED OTHER THAN IN BARBECUE PITS. IF GREASE IS BEING USED IN A FRY COOKER, THE GREASE MUST BE TAKEN HOME WITH YOU AND NOT DISPOSED OF IN ANY TRASH CAN OR ANY PART OF THE PARK/CITY PROPERTY. **DISPOSING HOT COALS ON THE GROUND WILL FORFEIT YOUR DEPOSIT.**
4. **NO PARKING ON THE GRASS AT ANY TIME. THE GRAVEL LANE IN ST. JOHN PARK IS FOR LOADING AND UNLOADING ONLY. DO NOT STAY PARKED ON GRAVEL LANE.**
5. DOGS ARE ALLOWED AT THE PARKS. HOWEVER THEY MUST BE ON A LEASH AND OWNERS MUST CLEAN UP AFTER THEIR PET. DISPOSABLE PET BAGS ARE PROVIDED AT THE PARKS.
6. BICYCLES, SKATEBOARDS, MOTORCYCLES, MOTORIZED VEHICLES, ETC. ARE NOT PERMITTED IN THE PARKS.
7. THE PARK OPENS 30 MINUTES BEFORE SUNRISE AND CLOSSES 30 MINUTES AFTER SUNSET.
8. ANY EQUIPMENT RENTED WITH THE PARK WHICH IS: NOT RETURNED, RETURNED DAMAGED OR IS MISSING PIECES, WILL HAVE A FEE DEDUCTED FROM THE RENTER'S DEPOSIT AS FOLLOWS:
WASHER GAME - \$30.00/SET WASHERS - \$1.00/EACH WASHER CONTAINER-\$1.00
VOLLEYBALL NET - \$35.00
9. RENTAL FEES WILL NOT BE RETURNED IF CANCELLATION OF RENTAL IS MADE TEN (10) WORKING DAYS OR LESS PRIOR TO THE EVENT DATE. **THE CITY DOES NOT REFUND RENTAL FEES DUE TO WEATHER.**
10. ALL EQUIPMENT MUST BE RETURNED BY 5:00 P.M. THE SECOND BUSINESS DAY AFTER THE EVENT OR A **\$5.00 PER DAY LATE FEE** WILL BE DEDUCTED FROM THE DEPOSIT.
11. ANY DAMAGE INCURRED TO THE PARK OR PARK EQUIPMENT WILL BE CHARGED AT THE CURRENT REPAIR/REPLACEMENT COST AND WILL BE CHARGED BACK TO THE RENTER.
12. ***OUTSIDE ACTIVITIES (SUCH AS PONIES, PETTING ZOO'S, ETC.) BROUGHT TO THE PARK MUST BE PRE-APPROVED BY THE CITY OF ST. JOHN WITH PROOF OF PROPER INSURANCE. NO KIDDY POOLS, SLIP 'N SLIDES OR ANYTHING INVOLVING WATER IS ALLOWED.**
13. **A MAXIMUM OF 60 PEOPLE ARE ALLOWED FOR RENTALS AT THE ST. JOHN PARK PAVILION. A MAXIMUM OF 50 PEOPLE ARE ALLOWED FOR EACH PAVILION RENTED AT HOME HEIGHTS PARK.**

PURSUANT TO THE MUNICIPAL CODE, VIOLATION OF THE ABOVE RULES ARE SUBJECT TO A FINE WHICH MAY REQUIRE A COURT APPEARANCE.

"No liability either expressed or implied, will be incurred by City, it's agents, servants, and employees, arising out of the use of the premises by renter, its agents, servants, employees, assigns, successors, invitees and licensees, during the date and time as specified on the reverse side of this form. Renter agrees to indemnify and hold harmless the City, its agents servants, employees, from and against any and all liability for damages arising from injuries to persons or damage to property occasioned by any acts or omissions of the renter, its agents, servants, or employees, including any and all expense, legal or otherwise, which may be incurred by City or its agents, servants, or employees, in defense of any claim, action or suit, irrespective of any claim that an act, omission or negligence of the City or its agents, servants, or employees contributed to such injury or damage".
